THE CURRENT SITUATION IN SINDH

The people of Sindh continue to suffer numerous rights violations at the hands of the Pakistani state. This includes enforced disappearances and extrajudicial killings of Sindhi political activists, the state-sponsored rise in religious extremism, persecution of religious minorities, misappropriation of natural resources, forced eviction and economic hardship due to large-scale infrastructure projects without consultation, and the complete denial of rights and opportunities for social, economic, cultural and political development. The state's actions have led to systematic discrimination, hostility, and the persecution of indigenous Sindhi people. Currently, the Sindhi people are facing the following rights violations:

Extrajudicial Killings and Enforced Disappearances of Sindhi Activists

Enforced disappearances and extrajudicial killings of political and human rights activists is the norm in Pakistan, where security agencies continue to operate with impunity. Released victims are detained for various lengths of time in which they undergo physical and psychological trauma, while others are killed in custody. By August 2021, the Federal Commission for the Recovery and Inquiry of Enforced Disappearances in Pakistan received 8,122 reports of enforced disappearances. Eyewitnesses to these disappearances indicate that the majority of perpetrators seem to be state-sponsored security personnel, i.e. rangers, police, and intelligence agencies. Despite domestic and international pressure, the Commission on Enforced Disappearances remains underfunded and lacks the necessary authority to properly investigate the hundreds of reported cases. While the Criminal Laws Amendment Bill 2021 seeks to provide stricter laws and better avenues of justice to victims, the state is working to actively undermine these efforts.

Massive Infrastructure Projects without Consultation or Consideration

Pakistan's continued dedication to massive infrastructure projects through the China-Pakistan Economic Corridor (CPEC) continues to fuel inequity within Sindh. State agents continue to move forward or support with damn projects, despite public outcries in Sindh. These initiatives will result in loss of traditional lands, the usurpation, and degradation of natural resources, and the loss of livelihoods. Historical mismanagement of such infrastructure projects and the lack of consideration given to how these projects will negatively impact local populations, putting the people of Sindh in a disadvantaged and dangerous position.



THE CURRENT SITUATION IN SINDH

Forced Conversions and Kidnappings of Sindhi Hindus

Sindhi Hindus face targeted discrimination and violence including. This pervasive violence has resulted in the exodus of the Hindu population out of Pakistan. Numerous cases have been reported of Hindu girls, the majority of whom were under the age of 16, being forcibly abducted and converted. In most instances, the girls were then forcibly married off or kept in the custody of their kidnappers with little to no recourse for the girls or their families. Families who reported the kidnappings were often the targets of violence.

Spread of Religious Extremism in Sindh

Islamic militarism across Pakistan is increasing, and Sindh continues to experience unprecedented violence against non-Muslim and non-Sunni sects of Muslims. Underage religious minority girls are the targets of kidnappings and forced conversions as textbooks and school curriculums teach intolerance and bigotry, further aggravating tensions between these groups. Several incidents of destruction and burning of Christian, Hindu, Sikh, and Ahmadi places of worship have been reported.

Misappropriation of Sindh's Natural Resources

Sindh remains one of the most resource-rich states of Pakistan with some of the largest oil and gas reserves in the world. These resources contribute to 69% of all of Pakistan's revenue, and Sindh has the only seaport in the country. Sindh has 71% of the gas fields in Pakistan, 62% of the oil of Pakistan, and one of the largest coal deposits in the world and 99% of Pakistan's total coal reserves (worth an estimated \$23 trillion). However, Sindh only receives 11% of federal funding and 60% of Sindhis live below the poverty line. 50% of the population has diseases borne out of inadequate sanitation, and a lack of health facilities and proper infrastructure. More than 60% of Sindhis do not have access to drinkable water. The Federal government relies on Sindh's resources but then appropriates funding unequally and inequitably in favor of Punjab, perpetuating Sindh's status as one of the poorest provinces in the country despite its contributions.

WSC has been vocal in exposing these injustices and advocating for the rightful ownership and use of Sindh's natural resources for the benefit of its people.



As I hand over the leadership to our new Chair, Dr. Lakhu Luhana, I do so confidently and optimistically. Dr. Luhana has been a beacon of human rights advocacy for Sindhis on international platforms, and I am certain that WSC will reach even greater heights under his leadership.



WSC Hosts 35th International Conference on Sindh on 12 October, 2023

The 35th annual World Sindhi Conference was organized by the World Sindhi Congress in London, UK. Conference topics included human rights, environmental justice, national self-determination, and peace and security in South Asia. Attendees traveled from the the United States, Canada, Europe, India, Great Britain, and beyond to participate.

WSC Chairperson Gives Statement on Sindh to United Nations on 30 November, 2023

WSC Chairperson Dr. Rubina Greenwood provided a statement to the United Nations 16th Forum of the UN Forum on Minority Issues Item 2: Socio-Economic Empowerment on the political and human rights situation in Sindh. Special attention was given to the forced conversion of religious minority girls, the widespread use of forced disappearances, the minoritization of Sindhi people within Pakistan, and the ongoing effects of the devastating floods in Sindh.

Notan Lal Released on 1 March, 2024

Notan Lal, a respected teacher from the Sindhi Hindu community, has been released after being wrongfully imprisoned for several years under false accusations of blasphemy.

WSC members protested, campaigned, and organized around the world for his release, submitting petitions and reports to the UK and Canadian Parliaments, the US Congress, and the US State Department over the course of three years on his behalf.

WSC gives statement at United States Commission on International Religious Freedom conference on 23 April, 2024

The IRF and other participating nations pledged to help raise the case of Priya Kumari and ongoing violence against Sindhi Hindus.

WSC Honors GM Syed's Legacy in Houston on 20 January, 2024








Celebration of Life held in honor of Suraiya Makhdoom on 9 June, 2024


WSC announces second annual conference on GM Syed on 9 August, 2024

Protest held in Geneva against Human Rights Abuses on 26 September, 2024





Anita Shah Lakyary


