The Current Situation in Sindh

The people of Sindh continue to suffer numerous rights violations at the hands of the Pakistani state. This includes enforced disappearances and extrajudicial killings of Sindhi political activists, the state-sponsored rise in religious extremism, persecution of religious minorities, misappropriation of natural resources, forced eviction and economic hardship due to large-scale infrastructure projects without consultation, and the complete denial of rights and opportunities for social, economic, cultural and political development. The state's actions have led to systematic discrimination, hostility, and the persecution of indigenous Sindhi people. Currently, the Sindhi people are facing the following rights violations:

Extrajudicial Killings and Enforced Disappearances of Sindhi Activists

Enforced disappearances and extrajudicial killings of political and human rights activists is the norm in Pakistan, where security agencies continue to operate with impunity. Released victims are detained for various lengths of time in which they undergo physical and psychological trauma, while others are killed in custody. By August 2021, the Federal Commission for the Recovery and Inquiry of Enforced Disappearances in Pakistan received 8,122 reports of enforced disappearances. Eyewitnesses to these disappearances indicate that the majority of perpetrators seem to be state-sponsored security personnel, i.e. rangers, police, and intelligence agencies. Despite domestic and international pressure, the Commission on Enforced Disappearances remains underfunded and lacks the necessary authority to properly investigate the hundreds of reported cases. While the Criminal Laws Amendment Bill 2021 seeks to provide stricter laws and better avenues of justice to victims, the state is working to actively undermine these efforts.

Massive Infrastructure Projects without Consultation or Consideration

Pakistan's continued dedication to massive infrastructure projects through the China-Pakistan Economic Corridor (CPEC) continues to fuel inequity within Sindh. State agents continue to move forward or support with damn projects, despite public outcries in Sindh. In addition to the dam projects, Bahria Town Karachi moves forward with its plans in the Malir District. Despite a ruling by the Supreme Court of Pakistan in 2018, BTK has not paid reparations and continues its illegal seizure of indigenous land. These initiatives will result in loss of traditional lands, the usurpation, and degradation of natural resources, and the loss of livelihoods. Historical mismanagement of such infrastructure projects and the lack of consideration given to how these projects will negatively impact local populations, putting the people of Sindh in a disadvantaged and dangerous position.

Forced Conversions and Kidnappings of Sindhi Hindus

Sindhi Hindus face targeted discrimination and violence including. This pervasive violence has resulted in the exodus of the Hindu population out of Pakistan. Within the last year, numerous cases were reported of Hindu girls, the majority of whom were under the age of 16, being forcibly abducted and converted. In most instances, the girls were then forcibly married off or kept in the

custody of their kidnappers with little to no recourse for the girls or their families. Families who reported the kidnappings were often the targets of violence.

Spread of Religious Extremism in Sindh

There are an estimated 20,000 new madrassas across Sindh, mostly funded by foreign money and under the patronage of the government. Islamic militarism is increasing, and Sindh is witnessing unprecedented violence against non-Muslim and non-Sunni sects of Muslims. Underage religious minority girls are the targets of kidnappings and forced conversions as textbooks and school curriculums teach intolerance and bigotry, further aggravating tensions between these groups. Several incidents of destruction and burning of Christian, Hindu, Sikh, and Ahmadi places of worship have been reported.

Misappropriation of Sindh's Natural Resources

Sindh remains one of the most resource-rich states of Pakistan with some of the largest oil and gas reserves in the world. These resources contribute to 69% of all of Pakistan's revenue, and Sindh has the only seaport in the country. Sindh has 71% of the gas fields in Pakistan, 62% of the oil of Pakistan, and one of the largest coal deposits in the world and 99% of Pakistan's total coal reserves (worth an estimated \$23 trillion). However, Sindh only receives 11% of federal funding and 60% of Sindhis live below the poverty line. 50% of the population has diseases borne out of inadequate sanitation, and a lack of health facilities and proper infrastructure. More than 60% of Sindhis do not have access to drinkable water. The Federal government relies on Sindh's resources but then appropriates funding unequally and inequitably in favor of Punjab, perpetuating Sindh's status as one of the poorest provinces in the country despite its contributions.

A Message from the Chair

The 2021-2022 year has been dedicated to advocacy, outreach, and humanitarian aid for the World Sindhi Congress. Numerous protests, petitions, fundraisers, and seminars to advocate and raise awareness on the human rights violations in Sindh were organized and attended by WSC around the world. WSC grew its media presence to better connect with members and fellow advocates, in addition to numerous statements, press releases, and interviews.

Sindh's current situation is marked by continuous human rights violations, an environment of fear and oppression, and . Enforced disappearances and extrajudicial killings continue unchecked, while measures to address the abuse are stalled. Indigenous Sindhi people are disproportionately and negatively impacted by these projects, which infringe on their lands, misappropriate their resources, and loss of livelihoods. Religious extremism continues to rise, driving Sindhi Hindus and other religious minorities from the province. In relation to this, cases of the abduction and forced conversion of Hindu girls and women in Sindh persist as a major issue.

Mismanagement of natural resources and manmade climate change resulted in a humanitarian crisis, as the monsoon rains that started in June of this year in Pakistan manifested into high floods that have led to massive destruction throughout the country. Of the affected areas, Sindh has seen the worst aftermath of the monsoon rains. 1,823,360 million houses were damaged from the flooding, 742,695 of which have been completely destroyed. The flood has also impaired 414,869 livestock and 3,773,707 acres of crop area. Over 11 million people were impacted by the flooding in Sindh and face challenges in continuing education, receiving adequate healthcare and resources, and being displaced from their homes.

Representatives from the World Sindhi Congress were able to meet with the United Nations Working Group on Enforced and Involuntary Disappearances (WGEID) a total of three times during 2021, where they raised the issue of disappearances in Sindh, and attended virtual sessions in the United Nations regarding widespread human rights abuses in Sindh. This year, we were also able to collaborate with other organizations to build relationships and advocacy networks. World Sindhi Congress worked with the AAPG, Voice for Sindhi Missing Persons, and many others to raise human rights issues with the international community. These connections regularly took the form of seminars that the World Sindhi Congress used to inform and engage with community members.

The work we have accomplished this year is possible because of our dedicated members and fellow defenders of human rights, whom we thank and honor for their efforts. The World Sindhi

Congress salutes human rights advocates for their unwavering support and efforts to provide humanitarian assistance to those impacted by the floods. The World Sindhi Congress salutes each of you.

The continued repression of democracy in Pakistan, along with the ongoing human rights crisis, contribute to a major security threat in the region. It is vital that WSC continues its advocacy in the coming year by working closely with other oppressed nations in Pakistan and partnering with other non-governmental organizations. With your support, we will continue our outreach with the United Nations and other international governments to advance human rights in Sindh.

Accomplishments



Dr Rubina Greenwood Elected as Vice-President of UNPO on 22 April, 2022

Dr Rubina Greenwood, Chairperson of WSC, was announced as one of the vicepresidents of the Unrepresented Nations and Peoples Organization at the General

Assembly in Washington, D.C. Dr. Greenwood was elected along with Elizenda Paluzie of Catalonia. Dr. Edna Adan Ismail, who represents Somaliland, was elected as President.

WSC Attends UNPFII in New York on 27 April, 2022

World Sindhi Congress delegate, Raja Dahar Joyo, attended the ongoing 21st Session of the United Nations Permanent Forum on Indigenous Issues (UNPFII) held at the UN Headquarters in New York.



Delegation Attends 49th UN Human Rights Council Session on 15-17 March, 2022

On 15 March, a WSC delegation joined a protest against human rights violations and attended a



conference on 'State of Human Rights and Civil Liberties in Pakistan and its Occupied Areas'. On 16 March, WSC organized a protest against human rights violations in Sindh and attended the Global Human Rights Defence press conference on the 'Human Rights Situation in China and Pakistan - Why It Matters for the World'. Delegates joined the Balochistan Human Rights Council to protest against human rights violations in Balochistan and attended the "Baloch Lives Matter" Seminar on 17 March.

WSC Statements during 50th session of the UN Human Rights Council in Geneva on 17 June, 2022

WSC Delegates presented the cases of arrests and registering cases against hundreds of peaceful participants paying tribute to Saeen GM Syed on his death anniversary on 27th April, protesting against Bahria Town on 6th June 2021, and the arrest of Aslam Khairpuri under sedition and terrorism charges at the 50th session of the UNHRC, as well as raising concerns over the lack of access to education for Sindhi children and the closing of schools in Sindh.





WSC Delegation Meets with WGEID on 10 May, 2022

A delegation from the World Sindhi Congress, joined by the relatives of victims, met with the United Nations Working Group on Enforced or Involuntary Disappearances during its 127th Session in Geneva. WSC requested the UN WGEID undertake a visit to Pakistan to assess the extent of enforced disappearances and speak with

victims, relatives, and human rights organizations.

WSC Delegates Present Memorandum to UN Secretary General on 24 September, 2022

WSC presented a memorandum to the UN Secretary General that requested the UN set up a committee to investigate the unprecedented floods, as the floods have left millions of Sindhi people stranded without



aid from the government of Pakistan. The letter requested an international effort for the relief and rehabilitation of millions of people devastated by flooding.



UNPO Submits Report on the Right of Self-Determination in Pakistan on 18 July, 2022

WSC joined the Unrepresented Nations and Peoples Organization in submitting an article for the Universal Periodic Review of the United Nations Human Rights Council on the right of self-determination of minority nations in Pakistan.

Canadian Foreign Affairs Minister Gives Statement on Human Rights and Blasphemy Laws on 28 April, 2022

Canadian Foreign Affairs Minister Hon' Mélanie Joly responded to WSC correspondence on human rights and blasphemy laws in Pakistan by stating that "the promotion and protection of human rights, including freedom of religion or belief, are an integral part of Canada's foreign policy, as well as a key priority for our engagement with Pakistan."





Canadian MP Sponsors
Petition Against
Blasphemy Laws on 5 May, 2022

As a result of WSC advocacy, Canadian MP Garnett Genuis has sponsored a Parliamentary Petition against blasphemy laws in Pakistan, forced conversion of Hindu Girls, forced abduction, and the Notan Lal Case.

APPG Inquiry Report Published on 18 May, 2022

The UK Parliament's All Parties Parliamentary Group on Pakistani Minorities produced an inquiry report on 'Abductions, Forced Conversions, and Forced Marriages of Religious Minority Women and Girls in Pakistan'. In the process of the inquiry WSC had meetings and contributed a brief including the status, data and underlying causes of forced conversions of Sindhi Hindu girls.





Activities



International Human Rights Day: Remembering Karima Baloch hosted by the Sindhi Baloch Forum on 11 December, 2021

WSC Condemns Murder of Satan Lal on 31 January, 2022

Satan Lal was a Hindu businessman murdered in Daharki in the province of Sindh of Pakistan on 31 January 2022, after after attempting to report multiple threats to his life. World Sindhi Congress called for the persecution of his killers and an end to religious violence in Sindh.




Protest in Toronto Organized by WSC, PCC, and BHRC on 17 August, 2022

Fundraiser for Flood Relief Begins on 4 September, 2022

Dr. Rubina Shaikh, Chairperson of WSC, announced a fundraiser to provide humanitarian aid to the over 20 million people in Sindh impacted by the cataclysmic flooding. Monsoons caused flooding across Pakistan in Sindh, Balochistan, South Punjab, and Khyber Pakhtunkhwa, with Sindh bearing 70% of the impact.


WSC Mourns Comrade Mohammed Saleh Billoo on 19 December, 2021
